CITY-COUNTY COUNCIL RESOLUTION NO. , 2009

A PROPOSAL FOR A COUNCIL RESOLUTION directing the Director and the Board of Parks and Recreation to consider the sale of city golf courses.

WHEREAS, the city owns and operates several golf courses; and

WHEREAS, the operation of these golf courses is under the control of the Board of Parks and Recreation; and

WHEREAS, there has been public discussion of changing the contractual arrangements for the operation of these golf courses; and

WHEREAS, it might be in the best interests of the city and its taxpayers to sell these golf courses, and

WHEREAS, there should be a feasibility study of the sale of those golf courses, NOW THEREFORE:

BE IT RESOLVED BY THE CITY-COUNTY COUNCIL OF THE
CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

SECTION 1. The City-County Council directs the Director of the Department of Parks and Recreation to cause to be conducted a feasibility study of the selling of the city's golf courses.

SECTION 2. On or before November 1, 2009, the Board of Parks and Recreation shall contract for a feasibility study of the sale of city golf courses, which shall include an appraisal of the market value of the real estate, if sold subject to the obligation to operate the golf courses for at least ten years after the sale.

SECTION 3. On or before February 1, 2010, such report shall be reviewed by the Board of Parks and Recreation.

SECTION 4. On or before April 1, 2010, the Board of Parks and Recreation shall forward the feasibility study along with its recommendation as to the sale of the golf courses to the City-County Council.

SECTION 5. This resolution shall be in full force and effect upon adoption and compliance with IC 36-3-4-14.
