A SPECIAL RESOLUTION recognizing the Center for Inquiry at School No. 2.

WHEREAS, the Center for Inquiry (CFI) at School No. 2 is one of 314 schools nationwide to be named a 2009 National Blue Ribbon School; and

WHEREAS, this award honors public or private schools, grade K-12, that are either academically superior or have made dramatic gains in student achievement and helped close gaps in achievement among minority and disadvantaged students; and

WHEREAS, the Center for Inquiry at School No. 2 is the only Indianapolis-area school to earn this honor and one of only seven schools in the entire state to receive a Blue Ribbon School designation from the U.S. Department of Education this year; and

WHEREAS, Principal Christine Collier credited the honor to the teachers, students, parents, staff and partners of CFI at School No. 2 for all the hard work of everyone; and

WHEREAS, the Center for Inquiry at School No. 2, along with all other schools that received the award, were honored at an awards ceremony in Washington, D.C. on November 3, 2009; now, therefore:
